- We may share your personal data with airsoft retailers from whom you wish to purchase realistic imitation firearms (RIFs), HM Customs & Excise or the UK Police.
- We will also add your personal data to the United Kingdom Airsoft Retailers Association (UKARA) database if you have asked us to do so.
- We may also share your personal data with any service providers, sub-contractors and agents that we may appoint to perform functions on our behalf and in accordance with our instructions, including payment providers, email communication providers, IT service providers, accountants, auditors and lawyers.
- We shall process your personal data in a manner that ensures appropriate security of the personal data, including protection against unauthorised or unlawful processing and against accidental loss, destruction or damage, using appropriate technical or organisational measures. All information you provide to us is stored on our secure servers. However, you acknowledge that no system can be completely secure.
